

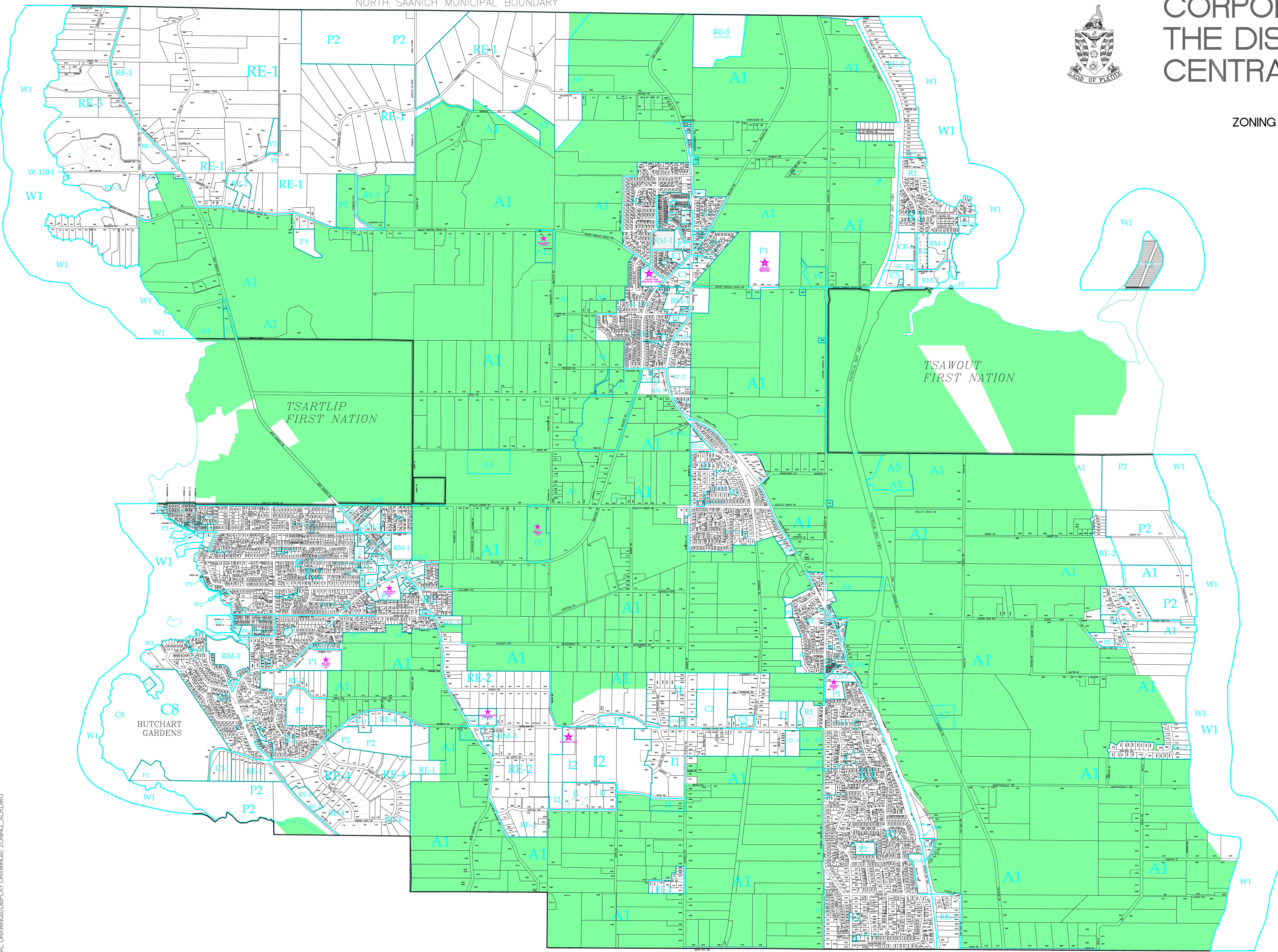
NORTH SAANICH MUNICIPAL BOUNDARY
